- Details of the arrangements to be made for the security of firearms and cartridge ammunition at the event when not being carried or used

**Note:**

**An application will not be approved if:**

- The commemorative or historical event has not been approved by the Chief Commissioner and/or the event is not being held at an approved shooting range
- An application is not made in the manner and form approved by the Chief Commissioner and accompanied by the name and licence number of each holder of a firearms collectors licence who proposes to carry or use any firearm held under his or her licence at a commemorative or historical event specified
- The prescribed fee is not paid for the permit at the time of application
- The Chief Commissioner is not satisfied of the arrangements made for the security of firearms and cartridge ammunition at the event when not being carried or used
- There is a risk to public safety and the peace

**Important Note:**

**No changes to a permit will be permitted after it has been issued. A new application would have to be submitted and another fee would be payable for a separate permit.**
