

# VICTORIA POLICE FEES & CHARGES AS DETERMINED BY POLICE REGULATION (FEES AND CHARGES) REGULATIONS 2024

#### **EFFECTIVE FROM 18 JUNE 2024**

Fees and charges are officially set and revised by legislation relevant to their application. The Victorian Government has a policy of automatically indexing certain fees and fines each year for inflation, so that the value of those fees and charges is maintained. This document outlines fees and charges for the purposes of:

- personnel and resources deployed to sporting, entertainment and other events where user charges are applicable;
- providing information or services as a defence witness in a criminal proceeding or as a witness for any other party in a civil proceeding;
- searching relevant police files and providing information from those files or supervising the examination of files;
- or providing information or services in an interview by a member of the public about an incident or accident reported to the Police Force including a search of files;
- providing a sworn affidavit; and
- calculation of restitution to Victoria Police for false reports made by members of the public.

Note fees and charges for Control of Weapons, Firearms Licence and Permit fees, Private Security licence and registration fees, Filming Service fees (including research assistance and onscreen interviews) are excluded from this list.

Below is an itemised list of the automatically indexed fees and charges effective from 18 June 2024. Fees are charged for the first hour or part thereof and subsequent half hour or part thereafter.
